

PRIVACY POLICY BY WEDIDIT SOLUTIONS

This Privacy Policy explains how Wedidit Solutions, uses, discloses, and protects your information, including any non-public personal information. This Privacy Policy applies to anyone who accesses and uses Komorebi.

This Privacy Policy, which must be expressly agreed to prior to accessing and operating Komorebi constitute your contract with Wedidit Solutions for use of Komorebi. By clicking “*I Agree*”, you expressly agree to be bound by (i) this Privacy Policy and any changes, amendments, and/or supplements to this Privacy Policy which may be made, (ii) any posted guidelines or rules applicable to Komorebi, which may be posted and modified from time to time by Wedidit Solutions, that you may be informed in any manner including a paper document, the communication channels, website or electronic device applications of Wedidit Solutions.

In this Privacy Policy, any reference to a singular includes a plural and a plural includes a singular. Where a word or expression is given a particular meaning other parts of speech and grammatical forms of that word or expression have corresponding meanings.

I. TERMINOLOGY

1. “*Wedidit Solutions*” refers to Wedidit Solutions Company Limited having (i) Enterprise Registration Certificate No.0313399086 issued on August 13, 2015 in Ho Chi Minh City, Vietnam, (ii) head office at No.414/3 Nguyen Thai Son Street, Ward 5, Go Vap District, Ho Chi Minh City, Vietnam and (iii) email: contact@wediditsolutions.com.
2. “*Komorebi*” refers to the business intelligence platform of Wedidit Solutions that allows you to access the Content about a Product that interests you and communicate with the partners and community in different ways through your smartphone when scanning the Tag attached to such Product.
3. “*Content*” refers to videos and images, graphics and all other information and materials shared by the Partners with you regarding their Products which is uploaded, posted or stored in a branded Product page.
4. “*Product*” refers to products which are produced and/or distributed by the Partners and attached with Tags that are scanned by you.
5. “*Tag*” refers to scannable information graphics which is attached to the Product.
6. “*Partner*” refers to manufacturers and/or distributors of the Product.

II. COLLECTION OF INFORMATION

To provide better services to all of Komorebi’s users, including you and the Partners, Wedidit Solutions shall collect your information through your access and use of

Komorebi in the following ways. Wedidit Solutions also reserves the right to accumulate anonymous demographic information that will be used to help improve Komorebi and the Partners' experience, and for research, including big data processing.

1. Information that you provide to Wedidit Solutions: Wedidit Solutions may collect non-public personal information when you operate and use Komorebi, or when you communicate with Wedidit Solutions and/or the Partners. The types of information Wedidit Solutions may collect include your name, address, phone number, email address, date of birth, primary language, username and any other information you choose to provide.
2. Information Wedidit Solutions collects automatically from Komorebi: When you access and use Komorebi, Wedidit Solutions automatically collects information about you as follows:
 - a. Device information: Wedidit Solutions collects information about the computer or mobile device you use to access Komorebi, including the hardware model, operating system and version, unique device identifiers and mobile network information.
 - b. Log information: Wedidit Solutions logs information, including type of browser, access times, pages viewed, your IP address, and the page(s) you visit while navigating Komorebi.
 - c. Location information: Wedidit Solutions may collect your location information from your mobile device with your prior consent.
 - d. Information collected by tracking technologies: Wedidit Solutions may use various tracking technologies to collect information, such as cookies and beacons.

III. USE AND DISCLOSURE OF YOUR INFORMATION

1. Wedidit Solutions endeavors to ensure that your personal information will be kept private and be used for certain purposes as follows:
 - a. To verify your identity and prevent fraud;
 - b. To provide, maintain and improve Komorebi;
 - c. To provide the Content of the Product(s) you show interest in;
 - d. To provide opportunities where you can share feedback with the Partners and potentially with other Komorebi's users as well as links where you can share your feedback on social networks for the Product(s) you show interest in;
 - e. To send you technical notices, updates, security alerts and support and

administrative messages;

- f. To respond to your comments, questions and requests regarding Komorebi and provide Wedidit Solutions' customer service;
 - g. With your consent, to communicate with you about the Products, services, offers, promotions, rewards, and events offered by the Partners, Wedidit Solutions and its third party clients, and others, and provide news and information Wedidit Solutions thinks they will be of interest to you;
 - h. To monitor and analyze trends, usage and activities in connection with the Product and Komorebi;
 - i. To personalize and improve Wedidit Solutions' service and provide advertisements (upon the policies of Wedidit Solutions from time to time and at Wedidit Solutions' sole discretion), content or features that match your profiles or interests;
 - j. To link or combine with information Wedidit Solutions obtains from others to help understand your needs and provide you with better service;
 - k. To satisfy Wedidit Solutions' legal obligations; and
 - l. To meet any applicable law and regulation.
2. Wedidit Solutions does not disclose your information to any other third party outside Wedidit Solutions and its Partners unless one of the following circumstance applies:
- a. With your consent: Wedidit Solutions will disclose partially or entirely your information to any other third party when having your consent to do so. Wedidit Solutions requires opt-in consent for disclosure of any sensitive personal information;
 - b. For external processing: Wedidit Solutions will provide your information to its affiliates or other trusted businesses or consultants, advisors utilized by Wedidit Solutions, based on Wedidit Solutions' instructions and in compliance with this Privacy Policy and any other appropriate confidentiality and security measures;
 - c. For legal reasons: Wedidit Solutions will disclose your information to other third parties if Wedidit Solutions has a good-faith belief that access, use, preservation or disclosure of your information is reasonably necessary to:
 - (i) Respond to an enforceable government request for information, if Wedidit Solutions is required by, or meet any applicable law, regulation or legal process;

- (ii) Defect, prevent or otherwise address fraud, security or technical issues; or
 - (iii) Protect against harm to the rights, property and safety of Wedidit Solutions, the Partner, Komorebi's users or others, or public as required or permitted by law.
- d. In connection with, or during negotiations of, any merger, sale of Wedidit Solutions' assets, financing or acquisition of all or a portion of Wedidit Solutions' business to another company.
- 3. Komorebi uses Google services. It adheres to Google Privacy Policy as stipulated at <https://policies.google.com/privacy> and YouTube Terms of Service as stipulated at <https://www.youtube.com/t/terms>.
- 4. Komorebi uses Meta services. It adheres to Meta Platform Terms as stipulated at <https://developers.facebook.com/terms/> and Meta's Developer Policies as stipulated at <https://developers.facebook.com/devpolicy>.

IV. YOUR PRIVACY OPTIONS

1. Account information: You may edit your profile information using Komorebi. If you wish to delete or deactivate your online account, you may do so, but note that Wedidit Solutions may retain certain information as required by the law or for legitimate business purposes.
 - a. Wedidit Solutions keeps records of your login account id for ease of access to your historical operations, such as scan and page access, your list of favorites, past event registrations, survey replies, purchases registered via the Komorebi platform, and for a smooth integration of messaging via the platform.
 - b. In case of an account deletion all your records will be lost and cannot be restored. If you would like to keep a record of your activities on Komorebi, kindly email us at contact@wediditsolutions.com when requesting a deletion of your account.
2. Promotional communications: You may opt-in to receive promotional emails and text messages from the Partners, Wedidit Solutions and others by following the instructions in those messages. Please note that if you do not opt-in, Wedidit Solutions may still send you transactional or relationship messages where necessary at Wedidit Solutions' discretion, such as those about your account or Wedidit Solutions' ongoing business relations.
3. Location information: You may disable the collection of location information by Wedidit Solutions within Komorebi, through your device operating system settings or through your online account settings. In the event that you download the Komorebi Application if available, the standard uninstall process to remove Komorebi from your device will also disable the collection of location information.

4. Cookies: You may set your browser to remove or reject browser cookies. Please note that if you choose to remove or reject cookies, this could affect the availability and functionality of Komorebi.
5. Social networking features: Komorebi may include social sharing features for common social networks to let you share information (the Content of the Product, the information of the Partner, your feedback on the Product and the Partners and/or functions of Komorebi, etc.) with your friends or the public, depending on the settings you establish with the network that provides the social sharing feature. While sharing information, you must adhere to the sharing policies as stipulated by the third party application you have shared with. For example, when sharing through Facebook or Instagram, you need to adhere to Meta and its related products' sharing policies for its users.
6. Advertising services provided by others: Komorebi is designed to provide you a third party ad-free experience; however, Wedidit Solutions reserves the right to change this policy. Wedidit Solutions may allow service providers to serve advertisements on its behalf across the Internet. If you click an advertisement, the service providers may also collect your information, which may be used by Wedidit Solutions or the service provider to, analyze and track data, determine the popularity of certain content, deliver targeted advertising and better understand your online activity.
7. Other than the cases stated in this Privacy Policy or permitted by the law, Wedidit Solutions commits to not selling, disclosing or leaking your information without your consent.

V. SECURITY MEASURES TO PROTECT YOUR INFORMATION

1. Your communication through Komorebi will be encrypted and your information will be protected through a usage of a third party intrusion protection software. Wedidit Solutions also takes reasonable measures to help protect all information about you from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction. Additionally, Wedidit Solutions implements policies designed to protect the confidentiality and security of your non-public personal information. Wedidit Solutions limits access to your non-public personal information to the Partners or anyone that has a business reason to know such information except for having your consent, and implements security practices and procedures designed to protect the confidentiality and security of such information and prohibit unlawful disclosure of such information in accordance with its policies.
2. Wedidit Solutions protects your information safely in a high security data center, adhering to stringent security controls, measures and protocols to safeguard the privacy of your information. While Wedidit Solutions shall use its best efforts to ensure that the privacy of all information is kept secure, please note that it is an accepted fact that no data transmission conducted over the Internet and/or through other electronic channels can be guaranteed to be wholly secure. As such, please ensure that your information is not accessible or disclosed to anyone. Further

thereto, Wedidit Solutions shall neither be held responsible nor liable for any damages or losses which you may suffer, whether directly or indirectly, as a result of the said information being stolen, tampered with, copied, abused, misused or otherwise violated.

VI. INTELLECTUAL PROPERTY RIGHTS

The contents of Wedidit Solutions website and Komorebi, including the logo, text, graphics, software, multi-media content, and UI/UX, is protected under both the Vietnamese laws and foreign laws. Unauthorized use of any content may violate intellectual property law and other laws. No content should be construed as granting, by implication, or otherwise, any license or right to use without Wedidit Solutions' prior written permission specific for each such use and/or as permitted by this Privacy Policy.

VII. YOUR COMMITMENTS

1. When you use Komorebi, you are required to strictly follow Wedidit Solutions' guidelines on operation and use of Komorebi, which may be changed from time to time;
2. Not to use, upload or post any comment, information or other content that is (i) pornographic, sexually explicit, or violent, (ii) illegal or infringing or having the potential to infringe the intellectual property rights of another, (iii) reasonably likely to cause harm, or that could be reasonably considered as slanderous or libelous, or (iv) breaches another's privacy.
3. Not to use Komorebi for any unlawful purposes or to conduct any unlawful activity, including, but not limited to, fraud, embezzlement, money laundering or insider trading;
4. Not to use Komorebi to impersonate any Partner, other person or organization; and
5. Not to upload, post, transmit or otherwise make available any comment, information or other content that contains software viruses, worms, Trojan horses or any other computer code, files or programs that interrupt, destroy or limit the functionality of Komorebi or that may impact the ability of other users to access Komorebi.
6. To the fullest extent permitted by law, you agree to indemnify and hold harmless Wedidit Solutions from and against all damages, losses and expenses of any kind (including without limitation reasonable attorneys' fees and costs) arising out of or related to: (i) your breach of this Privacy Policy; (ii) your breach or violation of the terms or use or policies of a third party sharing or social network (eg. Facebook or instagram); (iii) any claims from our Partners regarding your misuse of Komorebi; and (iv) your violation of any law or regulation or the rights of any third party.

VIII. PRICING

Using Komorebi is free of charge; however, Wedidit Solutions reserves the right to charge for additional premium services, which shall be informed to you before being applicable.

IX. DISCLAIMER

1. You acknowledge that Wedidit Solutions initially does not have the right to collect, use, disclose your information and that your consent to this Privacy Policy gives Wedidit Solutions such right. Therefore, you commit not to make any claim, complaint against, or hold Wedidit Solutions responsible in any way for its act of collecting, using, disclosing your information.
2. Though Wedidit Solutions facilitates the process of interacting with various Partners, Wedidit Solutions is not liable for the accuracy, truthfulness and legality of any Content of the Product, but the Partners under the Terms and Conditions that Wedidit Solutions applies to the Partners. If you come across any inaccurate, untruthful, or illegal Content of the Product, please notify Wedidit Solutions at contact@wediditsolutions.com as soon as possible.
3. Wedidit Solutions will not be liable for any breach of contract between the Partners and you, nor held accountable or responsible for any damage you may suffer due to such a breach in trust.
4. Though Wedidit Solutions strives to provide you with the best experience, with a bug-free and safe application, the usage of the application is at your own risk.
5. This Privacy Policy was originally written in English (US). Wedidit Solutions may translate this Privacy Policy into other languages. In the event of a conflict between a translated version and the English version, the English version will control.
